**SCHEDULE PART IIIB. - Disclosure Detail Concerning Private Investments

Rockefeller Financial Services, Inc. - (Class B shares) - Rockefeller Financial Services, Inc., through its subsidiaries, renders financial and personal services to members of the Rockefeller Family, to affiliated entities and to non-Family institutional and individual clients. These financial and personal services may be divided into four functional areas: investment management, accounting and tax, trust administration, and miscellaneous.

The following private investment pools listed in Schedule Part IIIB closely resemble mutual funds in that the reporting individual, spouse, dependent children and/or trusts have a relatively small percentage ownership, each entity has numerous investment transactions and holdings, and are managed by persons other than the reporting or related individuals. The nature of the activities of each are described below.

Pocantico Fund - This fund is a limited partnership which invests primarily in U.S. small companies.

Rockefeller Global Equity Fund III- These funds are limited partnerships with a diversified investment program in quoted large capitalization companies based both within and outside the U.S.

Venrock Associates - This Fund is a venture capital investment partnership.

The investment activities of these private investment pools are not reported in any financial reference publication. The information furnished, however is in conformity with Interpretative Ruling 425 (issued February 5, 1988) of the Select Committee on Ethics, U.S. Senate.
